TNT Coaches/Managers,

You will find below the date for **Game Scheduling**. You or a manager must attend the meeting. At the meeting you will compare your available ice times with other coaches and managers and select a day and that work you. If no one shows from you team, others will randomly schedule your games. This can be a major disadvantage as you might end up playing a strong team twice in one week and be done with them for the season. Or, you could end up with 2 – 3 back to back games, then have a week or two without any games. Ideally, you want to spread out games to 1 or 2 a week and have a decent gap in playing the second or third games. Call Jim Krings or Scott Jahnke if you have questions or know you won't have representation at your scheduling meeting.

12UA and 12UB Game scheduling occurs this coming Saturday in Roseville.

The **Leagues** changed significantly this year. It *appears* to me that many Districts do not have enough teams to support a league. As such, rather than split Districts/Leagues, Minnesota hockey is co-op'ing them. As you can see, everyone is going to be doing a lot more driving for away games.
